- **Slideshow Service:**

Our Standard package includes:

A professional slideshow, based on your photos, and selected music that you own, or that I purchase for you off the internet. This package includes special effects (zooming in on parts of your photos) and photo-to-photo transitions (fading from one photo to the next) and simple color correction and red-eye removal.

Each digital used picture in your show: \$1

Each photo that must be scanned: \$1.50

Each short video mpeg: \$1

Additional copies of your DVD: \$10

There is a \$50 minimum order charge, so a show with 1-50 digital photos would cost \$50, then \$1 per photo.

- **Billing Information**

Once this form has been sent back to *Joyciegirl DVD Creations*, a final cost will be determined, and I will call you or discuss it with you personally. The forms of payment I accept are: personal check (made out to Joyce Hopkins) or cash.

- **Slideshow Details**

Each photo takes approx 6 seconds...so 10 photos = 1 minute

I recommend between:

- 60 photos (producing a 6 minute show) to
- 130 photos (producing a 13 minutes show)

More photos that produce a longer show are fine, but most audiences would not enjoy sitting through a show that is much longer than 13 minutes (unless you are my family...we could watch ourselves forever). ☺

- **Music**

Music to be played during photos: (most songs are approx 3 minutes long, so a 12 minute show would need 4 songs). Because of copy write laws, you must own the music I use, or I can purchase it for you on the internet for \$1....you may not sell this slideshow...it is only for viewing enjoyment.

- **Traditional Photos:**

(Note: digital photos are photos that are either taken with a digital camera, or photos that have been scanned into a computer.) Please number the digital photos, burned onto a CD, in the order you would like them to appear in your show.
